

### Line 5808 – Age amount

#### Complete this calculation for each dependant.

Base amount If the dependant was **under 18 years of age** on December 31, 2015, enter the amount from line 5 of the chart for line 5844 for the dependant. If the dependant was **18 years of age or older**, enter "0".

Add lines 1 and 2.

Total of amounts your dependant can claim on lines 5804 to 5840 of his or her Form SK428

Add lines 3 and 4.

Dependant's taxable income (line 260 of his or her return)

Allowable amount for this dependant: Line 5 minus line 6 (if negative, enter "0") Enter on line 5848 of Form SK428 the amount from line 3 or line 7, whichever is **less**. Enter on line 5848 of Form SK428 the total amount claimed for **all** disabled dependants.

If at the end of the year you and your dependant were not residents of the same province or territory, special rules may apply. Contact the Canada Revenue Agency to determine the amount you can claim.

#### Line 6152 – Saskatchewan dividend tax credit

Calculate the amount to enter on line 6152 of Form SK428 by completing **one** of the **two** following calculations:

• If you entered an amount on line 120 but **no amount** on line 180 of your return, complete the following:





#### Line 57 – Saskatchewan political contribution tax credit

If your total political contributions (line 56 of Form SK428) were **more than \$1,275**, enter \$650 on line 57 of Form SK428.


