## FIRST NATIONS INFRASTRUCTURE INVESTMENT PLAN (FNIIP) **ANNUAL REPORT**

Purpose: The First Nations Infrastructure Investment Plan (FNIIP) - Annual Report, which has replaced the 5-year Capital Plan DCI, is an annual report which details a First Nation community's infrastructure needs, plans and previous year's accomplishments, and now captures projects that cross over fiscal years. This report is based upon the mandatory reporting requirements of the Recipient Reporting Guide, and is developed by communities with the support of AANDC Regional Offices. An updated report must be prepared once each year before capital funds are released to First Nations. This report **shall only include** eligible projects under the Capital Facilities and Maintenance Program and fit within the parameters of the National Priority Ranking Framework. The report shall only include the following projects:

- Projects that a First Nation is planning to undertake with their AANDC Formula-Based Capital "Band Base" Allocation or the "Block" funding.
- Proposal Driven or Formula funded projects towards which a First Nation is seeking AANDC funding/contribution. These projects will be assessed regionally against priority and are subject to available funding.
- ACRS projects that a First Nation cannot address through their Operations & Maintenance or their AANDC Formula-based Capital "Band Base" Allocation or "Block" funding. All ACRS deficiencies being addressed must be identified.
- This report shall include projects which are being funded through a First Nations Operation & Maintenance allocation.

Reporting Period: The previous reporting year, current fiscal year (to-date), remaining fiscal year ending March 31st and the next four years

**Due Date:** November 30<sup>th</sup>, each year

Exception(s): AB – September 1<sup>st</sup>, each year BC – October 15<sup>th</sup>, each year

ON - Sept 30<sup>th</sup> each year

QC – April 30<sup>th</sup>, each year SK – April 30<sup>th</sup>, each year

## **How to Enter a Project:**

There are two types of projects that AANDC considers relevant for the purpose of this DCI.

- 1. AANDC Proposal Driven Projects: These Projects are funded by virtue of application to the Capital Facilities and Maintenance Program. These projects may include funding from other sources including First Nation's own source revenue, the Province or other sources such as AANDC formula-based Capital or Block.
- 2. AANDC formula-based Capital Projects: These projects are undertaken at the First Nation level using funding that is allocated as part of a First Nation's formula-based Funding or their Block.
- 3. It is also important to identify which projects directly respond to an ACRS need and to specify whether this project will remediate a Health & Safety deficiency.
