News from our Members

HELPING CHILDREN AND FAMILIES

An Officer of the Order of Canada since 1992, and a member since 1987, George Cohon continues to contribute to the happiness and well-being of children and families across Canada and around the globe. As the founder of McDonald's Canada/Russia and of Ronald McDonald House Charities (RMHC) Canada/Russia, Mr. Cohon exemplifies the true meaning of the motto of the Order of Canada: "They desire a better country."

Since the first House opened in Toronto in 1981, Canada's Ronald McDonald Houses have served over 227 000 families of sick children. Today, 388 bedrooms in 14 Houses across Canada serve over 10 000 families a year. By 2014, it is expected that the charity will serve 20 000 families a year.

MAKING SMILES

"Happy surgery" is how Dr. David S. Precious refers to his team's work. For the past 17 years, Dr. Precious—a professor of oral and maxillofacial surgery and dean emeritus of Dalhousie University's Faculty of Dentistry—and a team of volunteer surgeons from Dalhousie have been joining forces with their Japanese counterparts to provide free cleft lip and cleft palate surgery for children in Vietnam and Tunisia.

Children with cleft lip and cleft palate have an opening between the nose and the mouth caused by a failure of the lip or the palate (or both) to fuse during prenatal development. "These babies have problems breathing, eating and, ultimately, speaking, among other things," says Dr. Precious.

The team treats approximately 50 children during each mission. They also train surgeons in the host country; the ultimate goal is to put themselves out of work by giving local surgeons the skills to deliver the service to their own people—an outcome that has already been realized in a number of locations since the program began.

Dr. Precious' surgical missions began shortly after he met a dynamic Japanese surgeon, Dr. Nagato Natsume, who is executive director of the Japanese Cleft Palate Foundation. "He was interested in the way we were changing the treatment methods for children, which differed from the standard practice of the day," said Dr. Precious. Dr. Natsume asked Dr. Precious to join his team on a mission to the remote province of Ben Tre, in south Vietnam. While there, Dr. Precious was asked to explain his new approach and techniques to the Japanese surgeons on the team. Dr. Precious was pleased with how the trip went, but realized that he wanted to do more. He wanted to include more surgeons from Halifax so the team could handle more patients and begin teaching the surgical techniques to the host country surgeons. He organized a group of surgeons from the QEII Health Sciences Centre and the IWK Health Centre, both in Halifax, to join the Japanese team on what are now annual missions. Their most recent missions took place in Vietnam, in November 2011 (where they had the pleasure of meeting His Excellency) and to Tunisia, in February 2012.

MAKING A DIFFERENCE

Dr. Precious has received several prestigious awards—including the Order of Canada—for his humanitarian work over the years. But what makes him truly happy is knowing that he and his team are making a difference in the lives of children in need.

HONOURING LOCAL MEMBERS OF THE ORDER

Local members of the Order of Canada living in and around the community of Guelph, Ontario, were recently honoured by the city's Rotary Club at a special luncheon to salute their contributions to Canada. The nine members received a standing



ovation as they were introduced. Her Worship Karen Farbridge, Mayor of the City of Guelph, addressed the guests, ending her speech with "We think you're great – and it's good to know that Canada does also." Gabrielle Lappa, Director of Honours at the Chancellery, was also invited to speak about Canada's national honours, and the importance of nominating and recognizing outstanding Canadians.

The nine members honoured at this event were famed country singers Tommy Hunter and Carroll Baker; the Honourable Bill Winegard, former president and vice-chancellor of the University of Guelph; James Sanders, a tireless advocate for visually impaired persons; children's book author Jean Little; renowned choreographer David Earle; community leader and philanthropist Ken Murray; celebrated metalsmith Lois Betteridge; and professor and scientist Robert W. Gillham.

VISITORS ENJOY NATIONAL HONOURS EXHIBIT IN OTTAWA

Six months and 36 000 visitors later, the Chancellery's national honours exhibit 'From Far and Wide – Honouring Great Canadians' closed on November 11, 2012. The temporary exhibit was located across from Parliament Hill and drew in visitors from across the country and around the globe. From the remarkable stories of brave and valiant Canadians, to video footage of the making of the Canadian Victoria Cross, and to the displays featuring Canada's medals and insignia, the exhibit offered young and old alike a chance to learn about the many outstanding Canadians who have been recognized through Canada's system of honours. A number of award ceremonies were also held at the exhibit site. Thanks to the vision of another outstanding Canadian and member of the Order who visited the site in June with his family, plans are underway to bring the exhibit to students and small communities across the country in 2013 and 2014. - 1. Appointment to The Queen's Privy Council (P.C.)
- 2. Orders (Order of Canada C.M. for Member, O.C. for Officer and C.C. for Companion). Post-nominals for all other Canadian Orders would follow.
- Decorations conferred by the Canadian Crown in accordance with the Canadian Order of Precedence (e.g. Bravery, Valour etc.) (see <u>www.gg.ca</u> for more information)
- 4. University Degrees
- 5. Honorary Degrees

 Religious Orders, Medical Qualifications, Fellowships of Learned Societies, Royal Academicians and Associates, Fellowships, Memberships of Professional Institutions, Associations, etc.

Example: The Honourable John Smith, P.C., O.C., O.B.C., LL.D., P.Eng.

Explanation: P.C. – Privy Councillor

O.C. - Officer of the Order of Canada

O.B,C, - Order of British Columbia

LL.D. - Honorary Degree

P.Eng. – Professional certification

Please note: Individual university degrees should not be included when one has progressed in the same faculty. Use only the highest distinction.

A SPECIAL REQUEST FROM HIS EXCELLENCY DAVID JOHNSTON

.... taken from the speech delivered at the November 23, 2012, Order of Canada Investiture.

'In saluting your achievements, I am especially conscious that each of you has voluntarily undertaken the profound responsibility of service. For that is the other side of the coin which captures the Order's motto: "They desire a better country." I ask one small favour in return. (...) During the past year, the staff of the Chancellery of Honours, in Ottawa, has been busy working on the many national honours programs that are administered by the Office of the Secretary to the Governor General. The stories that cross our desks each day are testaments to the character of our nation, whether we are working on nominations to recognize outstanding acts of military valour or preparing citations for extraordinary accomplishments in every field imaginable.

In 2012, more than 10 000 Canadians were recognized with the Order of Canada, orders of Military and Police Merit, Meritorious and Exemplary Service Medals, and military and civilian Bravery Decorations. In addition, more than 3 000 students from high schools, colleges and universities across Canada were recognized with the Governor General's Academic Medal, and close to 400 volunteers have been awarded the Governor General's Caring Canadian Awards. This year, to mark the 60th anniversary of The Queen's accession to the Throne, the Diamond Jubilee Medal is being awarded to 60 000 Canadians.

The Canadian Heraldic Authority, also part of the Chancellery of Honours, was responsible for the granting or registration of more than one hundred coats of arms and other heraldic emblems over the past year.
