



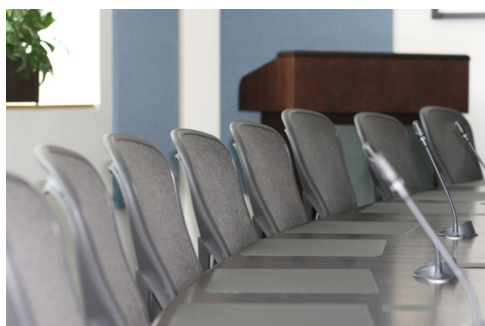

FPCC June Meeting

The Farm Products Council of Canada's (FPCC or Council) met on June 13, 2016, in Halifax, Nova Scotia. Here is a summary of the discussions and decisions.

Decision on EFC's Quota Regulations

Council concluded that it did not have sufficient legal information to be satisfied that the proposed amendment is necessary for the implementation of **Egg Farmers of Canada's** (EFC) Marketing Plan. Council therefore opted to postpone its decision until September 21, 2016, to explore this legal question and possible solutions with EFC.



Decision on TFC' Quota Regulations

With respect to **Turkey Farmers of Canada's** (TFC) request to amend the *Canadian Turkey Marketing Quota Regulations, 1980* for the current 2016-2017 control period (May 1, 2016, to April 29, 2017), Council members decided to postpone their decision pending further discussions with the TFC directors on this matter.

Decision on CHEP's Levies Order

Council members reviewed the **Canadian Hatching Egg Producers** (CHEP) 2016 budget and approved CHEP's request to amend the expiry date of the *Canadian Broiler Hatching Egg Marketing Levies Order*. The levy rate is maintained at \$0.0032 per broiler hatching egg and the Levies Order is effective on the date of registration and expires on June 24, 2017.

Decision on Canada Beef's Levies Order

Council members approved the proposed amendment to the *Beef Cattle Research Market Development and Promotion Levies Order*, as requested by the Agency's Board of Directors. The expiry date was extended to September 30, 2016, while the levy remained unchanged.
