Preamble

Whereas it appears by message from Her Excellency the Right Honourable Michaelle Jean, Governor General of Canada, and the Estimates accompanying that message, that the sums mentioned below are required to 5 defray certain expenses of the federal public administration, not otherwise provided for, for the financial year ending March 31, 2010, and for other purposes connected with the federal public administration;

May it therefore please Your Majesty, that it may be enacted, and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, that:

1. This Act may be cited as the *Appropriation* Act No. 2, 2009–10.
