SUBJECT: Re: Complaint pursuant to clause 7(1)(f) of the *Farm Products Agencies Act*, and clause 5(b) of the Farm Products Council of Canada Interim Complaint Guidelines from the Agri-Food Council of Saskatchewan regarding the A-133 allocation decision made by Chicken Farmers of Canada.

The following is to advise you that, in accordance with paragraph 7.h. of the Farm Products Council of Canada (FPCC) March 9, 2011, Interim Complaint Guidelines, FPCC's Chairman, Mr. Laurent Pellerin, has elected to establish a Complaint Committee.

This Complaint Committee is composed of Ms. Maryse Dubé as Chair, and Ms. Debbie Etsell as Committee member. The Committee will inquire into the July 15, 2015, complaint filed by the Agri-Food Council of Saskatchewan, regarding the A-133 allocation decision made by Chicken Farmers of Canada.

Following discussions with the parties, it was agreed that an informal one-day meeting will be held on August 4, 2015 in Ottawa. Should you wish to provide comments to FPCC or seek Intervener status, we ask that you do so by July 29, 2015.
