The following is to advise that on August 14, 2015, the Chairman of Farm Products Council of Canada (FPCC) met with the parties to the complaint; Ontario Broiler Hatching Egg and Chick Commission (OBHECC) and the Canadian Hatching Egg Producers (CHEP) to further discuss the subject matter of the complaint.

In accordance with paragraph 7.g. of the FPCC March 9, 2011, Interim Complaint Guidelines, FPCC's Chairman, Mr. Laurent Pellerin, has elected to establish a Complaint Committee. This Committee is composed of Ms. Debbie Etsell as Chair and, Mr. Mike Pickard as Committee member.

Should you wish to provide comments to the Committee or seek intervener status, we ask that you do so by forwarding to the Registrar, the information required under paragraph 5.d. of the Complaint Guidelines, no later than August 24, 2015. Industry stakeholders that have already submitted comments or requested intervener status, are not required to submit for a second time.

Once the period to seek intervener status has ended, the Complaint Committee may convene a conference call with parties and interveners to discuss the process, timelines and any other issues relevant to the handling of the complaint.

Documentation submitted by the parties, stakeholders and interveners in relation to the complaint will be posted on FPCC's Web site as they become available.
