SUBJECT: Complaint pursuant to paragraph 7(1)(f) of the *Farm Products Agencies Act* with regard to Turkey Farmers of Canada's decision made on June 11, 2015, and with regard to the TFC Multiplier Breeder Policy and Turkey Farmers of Ontario

The following is to advise you that, in accordance with paragraph 7.h. of the Farm Products Council of Canada (FPCC) March 9, 2011, Interim Complaint Guidelines, FPCC's Chairman, Mr. Laurent Pellerin, has elected to establish a Complaint Committee.

This Committee is composed of Mr. Mike Pickard as Chair and, Ms. Kimberley Hill as Committee member. The Committee will inquire into the July 10, 2015, complaint by Turkey Farmers of Ontario (TFO) regarding Turkey Farmers of Canada's (TFC) June 11, 2015, decision concerning the TFC Multiplier Breeder Policy.

Should you wish to provide comments to the Committee or seek intervener status, we ask that you do so by forwarding to the Registrar, the information required under paragraph 5.d. of the Complaint Guidelines, no later than August 28, 2015.

Once the period to seek intervener status has ended, the Committee may convene a conference call with parties and interveners to discuss the process, timelines and any other issues relevant to the handling of the complaint.

Documentation submitted by the parties, stakeholders and interveners in relation to the complaint will be posted on FPCC's Web site as they become available.
