SUBJECT: Complaint pursuant to paragraph 7(1)(f) of the *Farm Products Agencies Act* with regard to Turkey Farmers of Canada's decision made on June 11, 2015, and with regard to the TFC Multiplier Breeder Policy and Turkey Farmers of Ontario

The following is to advise that Farm Products Council of Canada (FPCC) has received a complaint from Turkey Farmers of Ontario (TFO) against Turkey Farmers of Canada (TFC) related to TFC's decision of June 11, 2015 with respect to the TFC Multiplier Breeder Policy. FPCC has reviewed the complaint and determined that they meet the requirements of paragraph 7(1)(f) of the *Farm Products Agencies Act* and has therefore accepted the complaint.

At the request of and on consent of the complainant and the respondent, the complaint process has been adjourned pending discussions between the parties. For the time being, the Parties have requested that the details of the complaint and supporting documents remain confidential. FPCC has agreed to this request for adjournment and confidentiality with a deadline of July 31, 2015. After this date, should the complaint proceed, FPCC will provide any necessary information on the complaint and process to all persons who express interest in intervening in the complaint process.
