Re: Incentives for English-Language Canadian Television Drama

In accordance with Broadcasting Public Notice CRTC 2004-93, we are pleased to enclose CTV's report on the English-Language Canadian Television Drama Incentive Program for the 2005/2006 broadcast year.

CTV is pleased to report that we used 48.5 minutes of the drama incentives in 2005/2006 out of the total of 63 minutes earned. CTV views this as a very effective program and we intend to make the fullest possible use of the incentives plan for 2006/07.

Pursuant to Section 20 of the *CRTC Rules of Procedure*, we respectfully request confidentiality with respect to the total production budgets, broadcaster licence fees and total licence fees for the qualifying programs listed as part of the report.

In accordance with the Commission's Confidentiality Guidelines as set out in Circular No. 429, programming costs for individual programs or series are treated on a confidential basis. As such, we understand that the total production budgets and broadcaster licence fees will be treated in a confidential manner. This information is highly sensitive, disclosure of which would be potentially harmful for CTV in the competitive marketplace and would potentially prejudice future negotiations for commissioning and acquiring programming. As every production is different and has different needs, CTV needs to be able to support each one differently according to those needs.

Accordingly, we request that the information as to production budget, broadcaster licence fees and total licence fees, be treated on a confidential basis. This information is being filed under separate cover.


We would also like to take this opportunity to inform the Commission that due to an inadvertent error, a total of 15 minutes per hour of commercial time aired in CTV's broadcast of the "Primetime Emmys" on August 27, 2006, in excess of the maximum amount permitted of 14 minutes per hour, in each of the three hours of the telecast. CTV would like to apologize to the

Commission for this inadvertent human error, related in part to the live nature of this program and related in part to the drama incentives being a new program. CTV would like to advise the Commission that it has reviewed its systems as a result of this error, and that every effort will be made to avoid any such error recurring in the future.

Please also be advised that no minutes from the drama incentives were used on The Comedy Network, The NHL Network, CTV Travel, ESPN Classic or Outdoor Life Network.
