Dear Mr. Traversy:

Re: Northwestel Inc. Tariff Notice No. 900.

Attached for the Commission's approval is a proposed revision to Northwestel's General Tariff (CRTC 3000) Item 807.7.a to introduce a 2-year contract rate for large Centrex customers with more than 1751 lines.

The Company proposes the new rate as a result of customer demand. The new proposed rate of \$35.23 is higher than the existing 3-year rate for the same number of lines but lower than the 3-year contract rate for large customers with 500 to 1751 lines.

Pursuant to Telecom Decision CRTC 2008-74, *Approval mechanisms for retail and CLEC tariffs*, the Company certifies that this tariff filing is a group B tariff change as defined by the Commission in Decision 2008-74.

Northwestel notes that per Telecom Decision CRTC 2007-5, this service is uncapped.

The Company proposes an approval date of 24 May 2013, and an effective date of 01 June 2013.
