

# Financial selective assistance for Canada-France co-productions (mini-treaties)

# **Information document**

Updated April 10, 2006

Additional agreements have been signed between Canada and France that allow for the allocation of special financial selective assistance to certain coproduction projects.

Telefilm Canada receives applications for financial assistance submitted under the three Canada-France mini-treaties:

- Canada-France mini-treaty Film (production);
- Canada-France mini-treaty Animation (production); and
- Canada-France mini-treaty Television (development).

#### **Canada-France mini-treaties**

Dramatic feature films, animation works of any length, animation series and French-language projects destined for initial release on television are eligible for selective assistance in each of the two countries, in accordance with the conditions outlined below.

Projects for which financial selective assistance is being sought under the Canada-France mini-treaties must be submitted to the competent Authorities of the coproducing countries. They must comply with the relevant Agreements signed between Canada and France, and meet the following requirements:

### The eligible phases are, respectively:

- Film: production phase, once a preliminary recommendation (advance ruling) has been obtained;
- Animation: production phase, once a preliminary recommendation (advance ruling) has been obtained; and
- Television: development phase, no preliminary recommendation (advance ruling) required.

## Certain special conditions apply under these mini-treaties:

- **Dramatic feature films**: priority is given to French-language projects.
- **Animation**: priority is given to the following projects:
  - Any one cycle of a series;
  - Incurring a significant portion of its costs in Canada or France; and
- **Television**: French-language development projects for which a broadcaster from either coproducing country has issued a letter of interest.

Canadian producers must complete an application form for preliminary recommendation, which includes a section for those productions seeking support under the Canada-France mini-treaties for film or animation production. In the case of television development, an application for financial selective assistance for the development of an original French-language program must be completed. Forms are available on Telefilm Canada's Website (www.telefilm.ca).

As well, with regard to Canada-France mini-treaties in production (film and animation), co-producers must provide the competent authorities with all information required for a preliminary recommendation (advance ruling) (for details, see <u>Coproduction guidelines</u>, <u>sections 2 and 3</u>).
