## **SECTION 4. FIRST-AID MEASURES**

## **First-aid Measures**

### Inhalation

Remove source of exposure or move to fresh air. Call a Poison Centre or doctor if you feel unwell.

### **Skin Contact**

## **Extinguishing Media**

## **Suitable Extinguishing Media**

Carbon dioxide, dry chemical powder or appropriate foam. Use water to keep non-leaking, fire-exposed containers cool.

## **Unsuitable Extinguishing Media**

None known.

## Specific Hazards Arising from the Product

Highly flammable liquid and vapour. Can ignite at room temperature. Releases vapour that can form explosive mixture with air. Can be ignited by static discharge.

May travel a considerable distance to a source of ignition and flash back to a leak or open container. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, resulting in a health hazard.

Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide. As well, other toxic and irritating compounds, such as formaldehyde, methanol, acetic acid, hydrogen peroxide, methane and ethylene oxide may be formed, depending on fire conditions.

## Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Approach fire from upwind to avoid hazardous vapours or gases.

Stop leak before attempting to put out the fire. Product could form an explosive mixture and reignite. Keep containers cool to avoid bursting.

Before entry, especially into confined areas, use an appropriate monitor to check for: toxic gases or vapours,

flammable or explosive atmosphere.

Dike and recover contaminated water for appropriate disposal.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

If there is potential for skin contact with concentrated cleaner: chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary. See Skin Protection in Section 8 (Exposure Controls/Personal Protection) for advice on suitable chemical protective materials.

## **SECTION 6. ACCIDENTAL RELEASE MEASURES**

## Personal Precautions, Protective Equipment, and Emergency Procedures

Concentrated product:

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Distant ignition and flashback are possible.

Increase ventilation to area or move leaking container to a well-ventilated and secure area.

Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Use the personal protective equipment recommended in Section 8 of this safety data sheet.

Review Section 7 (Handling) of this safety data sheet before proceeding with clean-up.

Before entry, especially into confined areas, check atmosphere with an appropriate monitor. Monitor area for flammable or explosive atmosphere.

#### **Environmental Precautions**

Concentrated product:

Do not allow into any sewer, on the ground or into any waterway. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas.

## Methods and Materials for Containment and Cleaning Up

Concentrated product:

Small spills or leaks:

Contain and soak up spill with absorbent that does not react with spilled product. Do NOT use combustible materials such as sawdust. Place used absorbent into suitable, covered, labelled containers for disposal.

Large spills or leaks: cover the spill surface with the appropriate type of foam to reduce the release of vapour. Dike spilled product to prevent runoff. Remove or recover liquid using pumps or vacuum equipment. Dike and recover contaminated water for appropriate disposal. Store recovered product in suitable containers that are: tightly-covered. Product (diluted as directed):

No special clean-up methods are necessary.

## **Other Information**

Report spills to local health, safety and environmental authorities, as required.

## **SECTION 7. HANDLING AND STORAGE**

## **Precautions for Safe Handling**

When handling diluted product:

No special handling precautions are necessary.

When handling concentrated product:

Do not get in eyes. Prevent all skin contact. Only use where there is adequate ventilation. Avoid generating vapours or mists. Electrically bond and ground equipment. Ground clips must contact bare metal. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Wear personal protective equipment to avoid direct contact with this chemical.

General hygiene considerations:

Do NOT smoke in work areas.

Wash hands thoroughly after handling this material.

Immediately remove contaminated clothing using the method that minimizes exposure. Keep contaminated clothing under water, in closed containers. Launder clothes before rewearing. Inform laundry personnel of product hazard(s).

### **Conditions for Safe Storage**

Concentrated product:

Store in an area that is: temperature-controlled, well-ventilated, out of direct sunlight and away from heat and ignition sources, an approved, fire-resistant area, separate from incompatible materials (see Section 10: Stability and Reactivity).

Protect from conditions listed in Conditions to Avoid in Section 10 (Stability and Reactivity).

Keep amount in storage to a minimum. Avoid bulk storage indoors.

Comply with all applicable health and safety regulations, fire and building codes.

### Skin Corrosion/Irritation
