SIGNIFICANT POINTS:

- <u>French Services</u> is currently in negotiations with three (3) bargaining units and artists' associations:
 - Société des auteurs de radio, télévision et cinéma (SARTEC) (Agreement ended on July 9th, 2012)
 - Société professionnelle des auteurs et compositeurs de Radio-Canada (SPACQ) (Agreement ended on January 7th, 2011)
 - Syndicat des techniciens et artisans du Réseau Français de Radio-Canada (STARF)
 (Agreement ended on March 31st, 2014)

• English Services :

- A new agreement with l'Alliance of Canadian Cinema, Television and Radio Artists (ACTRA) was attained and has been ratified. Agreement will end on June 30th, 2015.
- <u>English and French Services</u> are jointly in negotiations with one (1) national bargaining unit:
 - A new agreement with the Canadian Federation of Musicians (CFM) was attained and awaits ratification. Agreement would expire on September 30th, 2015.
