#### Response 2:

The requested information is not available, however, data from 33 CSC federal correctional institutions indicates the following as the top ten dental procedures provided in fiscal year 2015-2016:

- 1. Emergency/Specific oral examination and treatment planning
- 2. Bitewings, occlusal and periapical radiographs
- 3. Amalgam/composite restorations
- 4. Local Anaesthesia
- 5. Tooth and Root Extractions
- 6. Complete Dentures
- 7. Acrylic Partials
- 8. Minor repairs or re-cementation of fixed bridges
- 9. Dental Scaling
- 10. Repairs and Adjustments of removable complete and partial prosthesis
