Section I – Organizational Overview

Raison d'être

The National Battlefields Commission (NBC), as manager of Battlefields Park, enables Canadians to enjoy the first national historic park in Canada and one of the most prestigious urban parks in the world.

Responsibilities

The NBC is responsible for the administration, management, conservation and promotion of National Battlefields Park (located in the city of Québec) and manages funds allocated for this purpose.

The NBC takes its mandate from the *Act respecting the National Battlefields at Québec*, 7-8 Edward VII, c. 57, passed on March 17, 1908, and its amendments. It reports to Parliament through the Minister of Canadian Heritage and Official Languages. It is administered by a nine-member Board of Directors. Seven members are appointed by the Governor in Council and the NBC's enabling legislation authorizes the provinces of Quebec and Ontario to each appoint a member in recognition of their contribution at the time of the creation of the Commission.

The Board of Directors sets the overall direction for achieving the strategic outcome to make the Battlefields Park in Québec a prestigious, natural, accessible, safe and educational historic and urban site and is responsible for general oversight of the Park's operations.

The Secretary, who acts as Director General, is appointed by the Governor in Council and is responsible for implementation of policy and for day-to-day management of all NBC operations. He therefore works towards the attainment of the organization's strategic outcome as well as the targets for each program's expected results.

The grounds of the NBC constitute one of the most important historic sites in Canada. Commonly called the Plains of Abraham, the site is the largest urban park in Québec and ranks among the most prestigious parks in the world. The NBC must thus manage to balance the Plains of Abraham's historic significance with its role as an urban park. The NBC must preserve this heritage for future generations and develop it so that the public fully benefits from its rich resources and Canadians learn about the major events in Canadian history associated with this important site.


Strategic Outcome

The NBC works to achieve the following strategic outcome:

The Battlefields Park of Québec is a prestigious, natural, accessible, safe and educational historic and urban site.

Its role is to make Battlefields Park a prestigious national site, maintain its historic integrity while ensuring that its urban mission receives equal consideration, allow for its safe use, and offer activities and relevant services in line with its historic, cultural, recreational and natural-features.

Why is this a priority?		
Battlefields Park is a prestigious, natural, accessible, historic and urban site. The NBC must maintain park users' safety and site conservation.		
Plans for meeting the priority		
The NBC will continue to do general maintenance of its grounds and will make certain urgent and high-priority repairs in order to minimize the risks to users' safety and maintain appropriate facilities. For example: repairing pedestrian crossings, replacing the Grey Terrace flagpole.

Why is this a priority?		
In light of the issues involved in preserving the unique natural site of Battlefields Park and developing it for future generations, the objectives set out in the sustainable development action plan will enable the NBC to protect nature, the environment, and the well-being of Canadians.		
Plans for meeting the priority		
The NBC will review the past three years of its action plan and establish a second time frame for the plan. It will also continue awareness activities with employees and users, fostering a sustainable development approach.

Description		
Why is this a priority?		
Offering quality public services related to the park's educational, sociocultural and natural features is part of the NBC's mandate as manager of Battlefields Park, an important historic and urban site located in the heart of a city.		

Plans for meeting the priority

The NBC plans to continue to deliver its educational activities to various clients, including school groups and tourists, and to provide a variety of services to users, including cross-country ski trails. There are also plans to develop Martello Tower 4 (for educational activities) and to set up a 1-800 phone line to facilitate access to its services, including reservations for educational activities.

It will also continue to put on shows at the Édwin Bélanger Bandstand and thus provide opportunities for new artists.

The Great Celebration of Nature, Halloween activities and History Day will be renewed, and will contribute to the vitality and community engagement of the organization.

Description		
Why is this a priority?		
Since Battlefields Park is a Canadian national historic park and a site of primary importance to the country, raising awareness of the Park's history and the historic events associated with it are vital parts of the NBC's mandate.		
Plans for meeting the priority		
The NBC plans to create a permanent exhibition presenting the artefacts discovered during archaeological digs on the grounds in recent years, and to run travelling exhibitions with museum partners.		
In addition, the database of soldiers from the battles of 1759 and 1760 will be made available online.

Description		
Why is this a priority?		
Because it is important to sustain a balance between those missions, between accessibility, preservation and development of the park, with a view to fulfilling the NBC's mandate and mission.		
Plans for meeting the priority		
The NBC will manage land use applications in accordance with the new policy.		

Risk Analysis

The retirement of a number of senior managers led to changes in the NBC's operational environment and an associated administrative reorganization. As a result, some employees have been assigned additional responsibilities, which will required the organization as a whole to adapt to this new structure.

In light of the various budgetary and economic issues that will arise in 2013-14, the NBC plans to achieve its objectives by exercising proactive management and optimizing its financial, material and human resources.

The NBC will roll out its new land use policy over the next year, which features a new fee schedule and ensures the preservation of the park as well as a better balance between the needs of users and activity organizers. Considering pressures from different groups with sometimes opposing interests, some challenges lie ahead. Monitoring measures will be introduced to ensure compliance with agreements. Ongoing collaboration between NBC staff and its partners will help to achieve the new policy objectives.

The NBC has to deal with external factors beyond its control, including poor weather and economic conditions. Those factors may reduce participation in educational activities or exhibitions offered by the NBC, as well as park attendance, resulting in revenue losses. Achieving its revenue objectives is an important priority which will allow the NBC to pursue its mission of preserving and developing the park.

Considering the major impacts associated with the decision regarding the potential opening of Gilmour Hill in the winter, the announcement will likely generate widely varied public opinions.

As we can see, the sub-total does not vary greatly year over year. The variations in the different programs for 2010-11 and 2011-12 are a result of the year-end revenue surplus divided between the two programs based on incurred expenditures. However, for 2012-13, since the planned revenues according to the Main Estimates is lower than the actual revenues in 2011-12, the amounts to be spent in both programs are also lower.



The fluctuation can be explained as follows:

- In 2009-10 supplementary funding was obtained for wages and for the employee benefit plan (EBP). A funding carry-over was approved for the renovation of the Commission's administrative offices. An operating budget carry-over was also transferred.
- In 2010-11, a budget carry-over was authorized to renovate the administrative offices. NBC exceeded its estimated revenues by \$631,000. A budget carry-over was authorized for 2011-12.
- In 2011-12, the NBC exceeded its estimated revenues by \$415, 612. A budget carry-over was authorized for the next year.
- In 2012-13, in accordance with Budget 2012, there was a \$130,000 wage cut. A funding carry-over from the previous year was included.
- In 2013-14 and subsequent years, in addition to the wage cut in 2012-13, there will be an operating budget reduction of \$599,000. No supplementary funding or funding carry-over is anticipated.

SECTION II: Analysis of Program by Strategic Outcome

Strategic Outcome:

The Battlefields Park of Québec is a prestigious, natural, accessible, safe and educational historic and urban site.

The role of the NBC is to make Battlefields Park a prestigious national site, maintain its historic integrity and ensure that its urban mission receives equal consideration, allow for its safe use, and provide activities and relevant services in line with historic, cultural, recreational and natural features.

This section presents the NBC's program, expected results, performance indicators and related objectives. It also sets out the financial and human resources that will be allocated to each program activity. Two programs support the strategic outcome: "Conservation and Development" and "Public Education and Services".

Program Description: Conservation and Development

Through this program, the NBC preserves the integrity of Battlefields Park for future generations by maintaining and improving, when required, infrastructure, landscaping and horticulture, and offering a safe site for Canadians and foreign users and visitors.

Planning Highlights:

To keep Battlefields Park's facilities in good condition and preserve the Park over the long term, the NBC plans to:

- proceed with general maintenance of the Park;
- carry out the most urgent and high-priority repairs, such as pedestrian crossings and replacement of the Grey Terrace flagpole;
- sustain a balance between the historical mission and the urban mission, between accessibility, preservation and development;
- hold meetings to conduct the review of the sustainable development action plan and establish a second time frame for its implementation;
- continue sustainable development awareness activities with employees and users, in order to foster a healthy environment.

Program Description: Public Education and Services

The purpose of this program is to showcase the history of the site and its sociocultural, recreational and natural features so as to emphasize its dual role as a historic and an urban park. In support of this activity, the NBC welcomes visitors, presents exhibits and educational activities and provides high-quality public services.

Planning Highlights:

With a view to promoting the history and features of Battlefields Park, the NBC plans to carry out the following activities:

- facilitate and expand services to the public by introducing a 1-800 line for all its services and for reservations for educational activities and exhibitions;
- make the database of soldiers from the battles of 1759 and 1760 available online;
- acquire a new, more modern bus (the old one is past its prime) to benefit users participating in historical activities;
- establish a new permanent exhibition of the artefacts found during archaeological digs on the grounds, including in Des Braves Park and the major event site (Cove Fields).
- establish partnerships to develop travelling exhibitions on the artefacts;
- develop Martello Tower 4 for educational activities.

Program Description: Internal Services

Internal Services support the achievement of the NBC's strategic outcome as well as its programs in accordance with the NBC's mandate and vision, its allocated budget and government policies.

Internal Services encompass related activities and resources that are administered to support the needs of the program activities and other obligations the NBC is subject to. These services are indispensable for the sound and responsible management of the NBC's programs. They consist of administrative services, financial services, communications services, legal services, management and oversight services, information technology services, information management services, real property services, materiel services and acquisition services.
