



### Selected Files List

On March 19, 2020, the Federal Court of Appeal announced a temporary suspension of filing deadlines set out in the *Federal Courts Rules*.

#### Selected Files

On [June 11, 2020](#), the Court announced a gradual phase out of that Suspension Period for “Selected Files”.

For “Selected Files” as described in the [Notice to Parties and the Profession dated June 11, 2020](#), time will begin to run under the *Federal Courts Rules*, orders and directions from the Monday following the file’s appearance on the Selected Files List. For the purposes of computing time, the Monday on which the Suspension Period ends will not be counted.<sup>1</sup>

#### Deselected Files

On [April 21, 2021](#), and due to a deterioration in the public health situation in some jurisdictions, the Court restored the Suspension Period in certain proceedings. Parties are encouraged to carefully review the [Notice to Parties and the Profession dated April 21, 2021](#), to ensure a proper understanding of the scope and nature of the Suspension Period.

Deselected files (i.e. files for which the Suspension Period applies until further notice) are identified as such in the list below. The Suspension Period will take effect on the next business day on which the file appears on the list with a “Deselected” status.<sup>2</sup>

Time will continue to run under the *Federal Courts Rules*, orders and directions in files that are not deselected.

#### Reselected Files

On [June 17, 2021](#), the Court announced that the public health situation has improved sufficiently to allow the gradual resumption of filing deadlines in all files.

All files that were deselected on April 26, 2021, and that were not otherwise reselected by order of the Court, are reselected in the June 21, 2021 list. The time in these files will begin to run under the *Federal Courts Rules*, orders and directions from the Monday following the file's appearance on the Selected Files List. For the purposes of computing time, the Monday on which the Suspension Period ends will not be counted.<sup>3</sup>
